
What We Do



Washington, D.C., had an estimated population of 711,571 in 2019, which makes it the 22nd most populous city in the United States. The median age in Washington, D.C., is 33.8 years, with a slight gender gap between female (52.5%) and male (47.5%) residents across the city.

According to the most recent American Community Survey, the racial composition of the District Of Columbia was:

- Black or African American: 47.75%
- White: 40.67%
- Other race: 4.60%
- Asian: 3.80%
- Two or more races: 2.87%
- Native American: 0.26%
- Native Hawaiian or Pacific Islander: 0.04%

Health Status

The health status of individuals is usually reflective of income, education, and levels of poverty. Those who have less tend also to have poorer qualities of health. There's an old saying in some African American communities that is often applied to the broad-stroke disparity of our nation's economy and health. "When white folks catch a cold, black folks get pneumonia."

According to the 2017 Annual Report of the Behavioral Risk Factor Surveillance System (BRFSS), the following data points were found:

- Wards 7 and 8 had a household median income of less than \$41,000 compared to all other wards whose household median income is more than \$60,000. Wards 2 and 3 had a household median income of greater than \$100,000.
- Heart disease and cancer were the top 2 leading causes of death.
- HIV was among the top 10 leading causes of death in Wards 5, 7, and 8.
- Diabetes was among the top 10 leading causes of death in all wards.
- Ward 3 residents were more likely to be diagnosed with high cholesterol, have health care coverage, and have an annual wellness exam. They are also more likely not to use a condom, never be tested for HIV, and diagnosed with arthritis, cancer, and depressive disorder.
- Ward 7 residents were more likely to have had difficulty remembering and concentrating, rate their health fair or poor, and be diagnosed with high blood pressure. They are also more likely to be obese, diagnosed with pre-diabetes, and had eaten fruit less than once per day and vegetables at least once per day. The residents are more likely not to have a flu shot, be diagnosed with arthritis, asthma, chronic obstructive pulmonary disease, diabetes, and heart disease.
- Ward 8 residents were more likely to have had difficulty remembering and concentrating, rate their health fair or poor, and be diagnosed with high blood pressure. They also cite having 14 or more days of poor mental health and are considered obese and pre-diabetic. While having an annual exam, they do not engage in exercise or eat fruit and vegetables once. The residents are more likely to be diagnosed with asthma, chronic obstructive pulmonary disease, diabetes, heart disease, and kidney disease.

As of December 31, 2019, the fundraising arm of The Ivy Foundation raised \$35,599, a 65% increase over the previous year (\$12,198). These fundraising efforts include revenue from the two fundraising events – Denim and Pearls Affair and Men Can Cook Too!, Amazon Smile, online giving, and other donations. All Foundation members were assessed a specific number of tickets for each event.

Denim and Pearls Affair

The Ivy Foundation's first fundraising event of 2019 was the Denim and Pearls Affair. More than 850 past donors and 230 Foundation members supported this event. The event, held at City Winery in Washington, D.C., on July 27, 2019. More than 260 tickets were sold. This event had a one ticket assessment or \$45.00 donation for all Ivy Foundation members. Total revenue generated was \$18,795.63, and expenses totaled \$4,903.75. The net income from this event was \$13,891.88.

Men Can Cook Too!

The second Ivy Foundation fundraising event was Men Can Cook Too! This event had a two-ticket assessment or \$90.00 donation for all Foundation members. The event was held at the Athletic Center of Trinity Washington University in Washington, D.C., on October 6, 2019. More than 320 tickets were sold. Total revenue generated was \$26,700.26, and expenses totaled \$9,623. The net income from this event was \$17,077.26.




